Through the Forum, you can exchange opinions, information and make queries regarding the products and services of Cyta.

Before making your first post, have a read of our user guidelines. We have these rules to make sure that the Community is a friendly and useful place to visit and search for information.

1. What is my role in the Community?

Our purpose is to build a thriving Community which you can help achieve by being positive and constructive with your posts, and by treating each other with respect.

Posting questions and answers on topics you may be familiar with should always be on topic.

Any post on the Forum expresses only the views of its author and is in no way adopted by Cyta or the users of the Forum.

2. Be specific

Users should give detailed questions, as well as specific and accurate answers in order to be understandable by all the users.

3. Stay on topic and post in the right boards

Posts about Cyta's products and services in the right topics and boards make it easy for others to find the information they are looking for.

4. Information accuracy

Cyta does not guarantee the accuracy of the technical information posted by the Forum users, since they are based on their own experience.

5. Posts should not:

- Be defamatory, threatening, abusive, harassing or invasive of a person's privacy
- Infringe a person's right of freedom of speech
- Be sexist, racist, profane, blasphemous, homophobic or be in any way discriminatory and/or offensive
- Promote violence or advocate, urge or assist any unlawful act
- Describe violent intentions towards other people or organizations
- Be pornographic, sexually explicit, obscene or lewd
- Infringe any copyright, trade mark or any other rights of any person or organization
- Violate any law in any way

6. Generating audio-visual content

All user generated audio-visual content should conform to the following:

- It should be a maximum of three minutes long
- Submission of any audio-visual content to the Forum constitutes that you are aware of and possess all the appropriate permissions

- Should not infringe the intellectual property rights of any person by unauthorized use of trademarks, logos or any other protected content owned by a third-party.

7. Discussions going off topic

8. Spam

Duplicate posts are not allowed, as well as spam posts such as advertisements for other web sites and services, or other advertising motivations, chain letters or pyramid schemes.

Discussions of P2P (peer to peer) software and the file sharing over the internet are allowed. However, sharing illegal copies of software is not allowed.

Do not post any personal details or information of yours, or anyone else's on the Forum.

Whatever is published on this public site is permanent and anybody can read your entries.
