## **Oculus Medium December Challenges**

## **OFFICIAL RULES**

## 3. How to Enter.

<u>Challenge 1</u>: To enter Challenge 1, during the Entry Period for Challenge 1 (set forth above), entrants will be asked to virtually sculpt a snowman utilizing Oculus Medium and submit three (3) screenshots and/or one (1):20 second video and link to your sculpt of your final artwork to <a href="mailto:medium@oculus.com">medium@oculus.com</a>.

<u>Challenge 2</u>: To enter Challenge 2, during the Entry Period for Challenge 2 (set forth above), entrants will be asked to virtually sculpt an item with the theme "winter solstice" utilizing Oculus Medium and submit three (3) screenshots and/or one (1):20 second video and link to your sculpt of your final artwork to <u>medium@oculus.com</u>.

<u>Challenge 3</u>: To enter Challenge 3, during the Entry Period for Challenge 3 (set forth above), entrants will be asked to virtually sculpt an item with the theme "holiday food" utilizing Oculus Medium and submit three (3) screenshots and/or one (1):20 second video and link to your sculpt of your final artwork to <u>medium@oculus.com</u>.

<u>Sweepstakes</u>: Individuals who submit entries for all three (3) Challenges (1-3) will receive an entry into a drawing for a chance to win the Grand Prize (defined below).

Each sculpt submitted is referred to herein as a "Submission" and must be made in Oculus Medium only and you may not use any external applications or tools. Screenshots must be taken with Oculus Medium photo tool and video must be taken with Oculus Medium video tool. Upon completing of your Submission, email 3 photos and or 1 (20 second) video of your Submission along with your name and title of your Submission prior to the conclusion of the applicable Entry Period to: <a href="medium@oculus.com">medium@oculus.com</a>. For purposes of this Promotion, a Submission is a video and or photograph file that follows the technical, creative, and legal requirements disclosed the materials promoting each Challenge and elsewhere in these Official Rules, including, without limitation, the Content Guidelines (defined below).

Limit of one (1) entry per person/email address for each Challenge and the Sweepstakes. A Submission may, in Sponsor's sole and absolute discretion, be rejected if it fails to follow the technical, creative, and legal requirements disclosed on the Promotion Website and in these Official Rules. Sponsor's designated database clock will be the official timekeeper for the Promotion. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified at Sponsor's sole and absolute discretion. Each Winner (defined below) may be required to show proof of being the registered account holder. If a dispute cannot be resolved to the Sponsor's satisfaction, the entry will be deemed ineligible. - **4.** <u>Submission Content Guidelines</u>. Submissions that do not meet the following "Content Guidelines" are subject to disqualification and/or removal from the Promotion Website (if applicable), each at Sponsor's sole and absolute discretion, so read and follow these Content Guidelines:

6. Representations, Warranties and Indemnity. By entering the Promotion, entrant represents and warrants that he or she has read, understands, agrees to and will follow the Official Rules. Entrant further represents and warrants that his or her Submission(s) and all materials and matter therein: (a) (except for elements that are within the public domain or are provided by Sponsor for inclusion in Submissions) are wholly original with such entrant and are not a copy or imitation of any other material or entrant has all necessary rights to grant the Sponsor the rights granted hereunder and exercise such without obligation or liability to any third party; (b) will not infringe or violate any right whatsoever, including, without limitation, any personal rights (e.g., defamation, privacy, false light, moral right, etc.) or any property rights (e.g., copyright, trademark, right to ideas, etc.) of any person or entity and the use thereof will result in no third party liability or obligations; and (c) is not the subject of any threatened or pending litigation, claim or dispute that might give rise to litigation, which adversely affects or in any way prejudices, impairs or diminishes the rights granted hereunder or the value thereof. Entrant further represents and warrants that he or she has the right to agree to and fully perform consistent with these Official Rules and that he or she has complied and has obtained all permissions, licenses and consents that are necessary for the submission of the Submission and the use of the Submission and to verify compliance with the foregoing requirements. Entrant agrees to provide to Sponsor at Sponsor's request copies of all such permissions, licenses and consents. Sponsor reserves the right, in its sole discretion, to disqualify and/or not to post on the Promotion Website any Submission that Sponsor determines does not comply with these Official Rules, to make such changes to any Submission as are necessary to make it compliant, or to require the entrant to do so. Entrant further acknowledges and agrees that he/she has not previously granted, assigned or otherwise encumbered his/her Submission, or any images, text and materials depicted therein, to any other third party. Further, entrant represents and warrants that Sponsor's use of any Submission, including any images, text and materials depicted therein, shall not violate an agreement to which such entrant has signed. Entrant agrees to indemnify and hold the Released Parties (defined below) harmless from and against any third party claims, to the extent arising out of or relating to any breach of any representation, warranty or covenant made by entrant in connection with his or her acceptance of these Official Rules or Promotion activities.

7. <u>Determining the Winner of each Challenge</u>. After the conclusion of each Entry Period, each Submission for each Challenge will be reviewed by a team of judges (the "**Judges**") assembled by Sponsor, who will review and judge all eligible Submissions for each applicable Challenge based on the following judging criteria (collectively, the "**Judging Criteria**"):

60 points: design creativity and uniqueness

30 points: interpretation and clarity of theme; and

10 points: presentation quality.

Based on the total score the Judges assign to each Submission using the Judging Criteria, one (1) winning Submission will be ultimately selected by the Judges for each Challenge and each individual who submitted a selected Submission will be potential "Winner" for that Challenge, subject to confirmation that the potential Winner has met the eligibility requirements and complied with these Official Rules. If there is a tie after the Judges apply the Judging Criteria, Sponsor will bring in a tie breaking Judge to apply the same Judging Criteria to break the tie and determine the Winner.

Sponsor may also recognize Submissions that were finalists (up to three (3)) through recognition on Oculus Medium social media platform(s) but this recognition has no retail value.

- **8.** <u>Determining the Winner of the Sweepstakes</u>. There will be one (1) winner selected in the Sweepstakes potion of the Promotion. The potential winner will be selected through a random drawing on or about December 22, 2017 from all individuals who submit one (1) entry for each of the three (3) Challenges.
- 9. Notification of Winners. Each potential Winner will be notified by mail, email and/or other method (as selected by Sponsor) on or about the dates set forth in Section 2 above unless extended by Sponsor. The winner of the Sweepstakes will be notified by mail, email and/or other method (as selected by Sponsor) on or about December 22, 2017. The Sponsor is not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email or other electronic message, one (1) day after sending via a delivery service or two (2) days after mailing. The potential Winners may be required to execute and return an affidavit of eligibility, a liability release, a publicity release and services and performances agreements (collectively, "Prize Acceptance Documents") within seven (7) days of date of issuance. If such documents are not returned within the specified time period, a prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential Winner or a potential Winner is not in compliance with these Official Rules, the prize will be forfeited and, at Sponsor's discretion, an alternate winner selected. Prizes are non-transferable, with no cash redemptions, equivalents or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and prize provider's rules and restrictions, and in the event that Sponsor is unable to provide a Winner with his/her prize(s), the Sponsor may elect, to provide Winner with the

approximate value of such item in cash or award an alternate prize of comparable or greater value. **16.** <u>Dispute Resolution</u>. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in San Mateo County, California and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.
