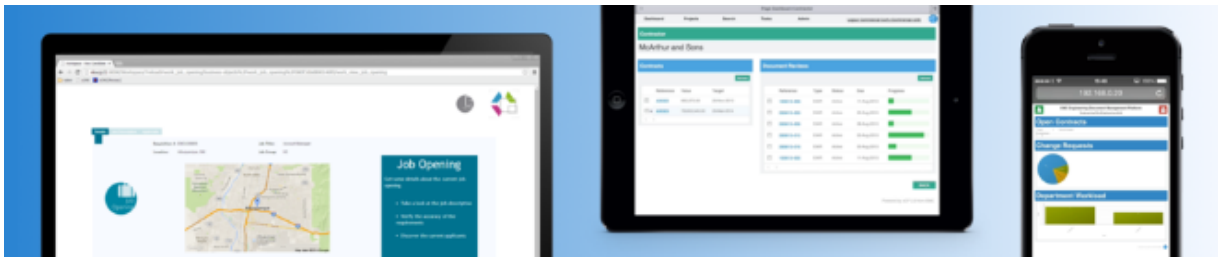

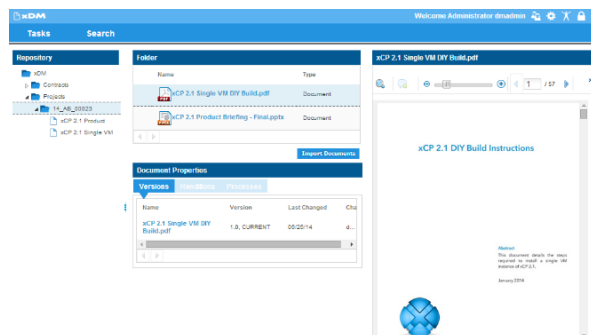

## xCelerated Case Management (xCMS)

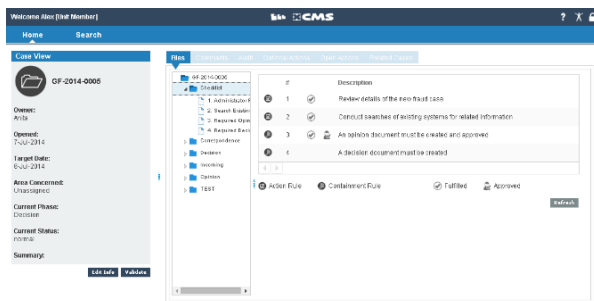
## xCelerated Document Management (xDM) **UPDATED**

Dynamic case management application that allows a business administrator to configure a case model at runtime, and manage the subsequent execution of that case model.

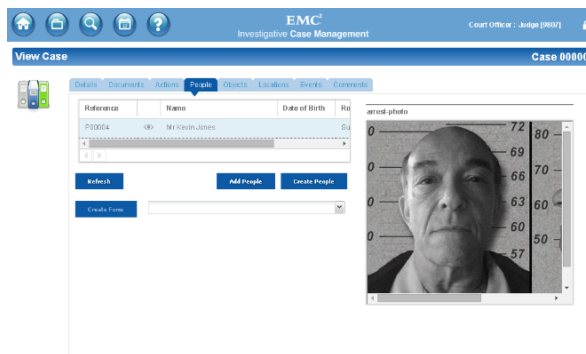

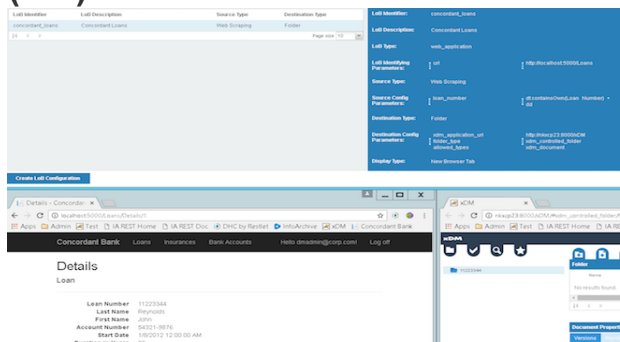

### NOTE ON MANIFEST SYNTAX FOR xCP 2.1 APPLICATIONS

Most sample applications include libraries (JAR files). These libraries require that the xCP execution environment specification in the file MANIFEST.MF inside the library matches your environment. If you are unable to import the sample application into Designer then use a tool like 7Zip to view the contents of the libraries and edit their manifest files. The correct syntax of the environment is 2.1.x where x represents the patch level of your environment (i.e. 2.1.3 for patch 03, 2.1.2 for patch 02 etc). The only exception to this rule is that for the GA release (no patch) the value 2.1.RC2 should be used.

PLEASE NOTE THAT THIS DOES NOT APPLY TO THE xCP 2.2 or 2.3 VERSIONS OF THESE APPLICATIONS
