

Contest - Nokia phones community contest

Following terms and conditions (the “Terms and Conditions”) shall apply to the Nokia phones community Contest (the “Competition”) detailed below. For the purposes of these Terms and Conditions, the term Organizer, when used with reference to a legal entity, shall mean HMD Global Oy (“Organizer”).

Eligibility

- This promotion is open to all forum users, aged 18 years as on 16/11/2018 or over. Proof of age may be required. Employees (or family members of employees) of HMD Global or companies associated with the promotion and all affiliates of such companies may not enter the promotion.
- The Participant must be a registered user of the Nokia phones community (“Platform”). Entries submitted on any other platform or otherwise will not be valid.

How to participate

- The participants need to sign-up to the Nokia phones community and join the contest thread created in the Nokia phones community saying “hello” and/or presenting themselves to the community.

- If the winners cannot be contacted or do not claim the prize within 48 hours of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
- The promoter's decision in respect of all matters to do with the competition will be final and no correspondence will be entered into. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.

- The promotion starts at 12:00 GTM on 16/11/18.
- All entries must be received by 23/11/18 12:00 GTM (the "Promotional Period").
