SECTION A – VEHICLE PARTICULARS

Motors PLC.” If the owner has a VAT number or a Trader Account Number (TAN) it should be entered in the appropriate box.
2. A list of index marks is available from any Revenue Registration Office
3. Where you are entitled to an exemption from VRT please state the exemption and insert the appropriate CODE in the sub box

SECTION D – DECLARANT

This box should be signed and dated by the person named or referred to in section C or, in the case of a company, by an authorised person.
